on the provision of consulting and educational services within the framework of the Want to Hear! Project

1. Client

Ministry of Preschool and School Education of the Republic of Uzbekistan (the "MPSE").

2. Services

Development of proposals on improving educational curriculums for the system of training and advanced training of, and retraining for teachers of the deaf (the "TOD"), as well as training of teaching staff on disciplines related to teaching in specialised educational institutions for persons with special educational needs (the "Special Schools") and teaching in Special Schools (the "Services").

4. Prolongation of the Terms of Provision

Term of provision of the Services may be prolonged subject to the consent of MPSE

5. Travelling Expenses

The expenses of the contractor in relation to the travelling of the employees, contractors and other persons engaged by the contractor for the purpose of the Services in relation to the Services shall be covered by the contractor.

6. Applicable Legislation

Legislation of the Republic of Uzbekistan.

7. Terms of Payment

Advance payment shall be in the amount of 15 percent of the total price of the Services. In the event that the total price of the Services is below 1 billion Uzbekistan soums the advance payment shall be in the amount of 30 percent of the total price of the Services.

Payment of the remaining total price of the Services is made upon providing parts of the Services specified in section 3 of this Statement of Work.

Payment guarantee from the Treasury Service Committee under the Ministry of Economy and Finance of the Republic of Uzbekistan may be secured for foreign suppliers.

8. Intellectual Property

Deliverables of the Services shall be owned by the MPSE.

9. Dispute Resolution

9.1. Dispute Resolution

Disputes shall be settled in accordance with the economic procedural legislation of the Republic of Uzbekistan.

At the request of foreign suppliers, disputes may be submitted for international commercial arbitration at the Tashkent International Arbitration Center in accordance with the Arbitration Rules of the Tashkent International Arbitration Center. The number of arbitrators shall be 3. MPSE and the contractor (the "Parties") each shall appoint one arbitrator, the arbitrators appointed by the Parties (the "Appointed Arbitrators") shall jointly appoint a third arbitrator. In the event that the Appointed Arbitrators fail to appoint the third arbitrator, each Party shall have the right to apply to the court to appoint the third arbitrator. The language of arbitration shall be English.

9.2. Technical disputes

To resolve technical disputes, the Parties shall jointly appoint a technical expert (the "Expert"). In the event that the Parties fail to appoint a technical expert within the agreed period, each Party shall have the right to apply to court to appoint the technical expert.

Each Party shall have the right to apply to the technical expert for obtaining an expert opinion on issues of a technical nature related to providing the Services (the "Technical Issues") and demand from the other Party to participate in the meeting with a technical expert where the Technical Issues are being discussed.
